This cause came on this day by consent of parties to be heard on the bill answer of the defendant Joseph T. Liles general replication and exhibits, and by like consent the Court, not settling any of the principles of the cause, but reserving them for adjudication at the final hearing, doth adjudge, order and decree that James Hall of Murphyboro rough in the state of Aborig Carolina, who is hereby appointed with the consent of all parties a Special Commissioner, settle an account of the co-partnership of Liles, Barnes &c. in the proceedings mentioned; that he ascertain as far as he can all outstanding debts due by the said firm and their respective amounts; and that he make a statement showing the amount due to and from each of the partners or their representatives, of such as are dead - all which he will report to the Court with such matters as he may deem convenient to be specially stated or which either of the parties may require to be stated.

This day this cause came on to be further heard on the papers formerly read and the report of James W. Murphy and Garrison Cobb, also of Wm G. Bourque made in obedience to an order of this Court pronounced at April Term 1843 to which reports there are no exceptions - and the Court affirms and adopts both adjudge order and decree that William C. Parker and James H. Williamson et al. are appointed Commissioners for that purpose, out of the cash returned with the report of Casperius Bott pay to James Cobb the sum of Eighty two dollars and five cents with interest on eighty one dollars forty six cents part thereof from December the 15th 1843 till paid being the balance due him on his administration account of David Cobb's estate. The Court doth further adjudge, order and decree that
