 which the testator was possessed into three equal parts and allot one part thereof
 to the said Elizabeth Gland to be held by her during her natural life and
 the remaining two parts after taking therefrom one share as are specifically
 bequeathed divide into eight equal parts and allot one part thereof to the said
 parts to Adeline Gland one part to F. J. Wickham second wife and one part
 to the said Powers wife and the remaining four equal parts equally between
 Joshua Cornelia Rosa Gland and that the said Commissioners make Report &c. and as to
 all other matters this case is moved for for further decree
