 Reports there is no exception on consideration whereof the Court doth approve order  
 and decree that the bill of the plaintiffs be dismissed and that they pay to the  
 defendants their costs &c. on this suit, respondents. But this decree is made without  
 prejudice to any suit which the defendant Clayton administrator &c. may think  
 proper to institute against the devisees and legatees of Elias Sumnerall &c.

 Robert Ridley and James Drowney and those of whom they act who are  
 hereby appointed Commissioners for that purpose do lay off and apportion to Elizabeth  
 Glend to be held by her during her natural life one third part in value of all  
 the lands of which Joseph J Glend died seized except the nine plantations and the  
 tract purchased of The D. Church that the same Commissioners divide the shares of  
 which the testator died possessed into three equal parts and allot one part thereof  
 to the said Elizabeth Glend to be held by her during her natural life and  
 the remaining two parts after taking therefrom and share as are specifically  
 bequeathed divide into eight equal parts and allot one part thereof to Asahel  
 Glend one part to J J Churchman second wife and one part  
 to Jos H Powers wife and the remaining four equal parts equally between  
 Joshua Cornelius Rosa Glend and that the said Commissioners make Report &c. and as to  
 all other matters this case is moved for for future docket
