Kello as the guardian of Mary V. Boykin, Edmund A. Boykin and Richard L. Boykin. And the said Commissioners directed in taking the said accounts to regard as prima facie correct but liable to be discharged and satisfied by the plaintiff offering solid evidence of the said administrators and guardians made under orders of a Court of competent jurisdiction and otherwise to and ordered to be recorded by such Court.
