Comptroller Howard, Made pursuant to the decree of the 5th of
November 1856, to which report there is no exception and was argued
by Counsel, the Court doth approve of the said Court doth approve the said
Report, and doth assign, Order and Sever, that George W. Dick,
(who is hereby appointed a Comptroller for that purpose,) proceed
to Sell before the Court House door of Southampton County, on some
Court day, in a Credit of Nine Months with Interest from date,
(except for a sum sufficient to pay the Costs of Suit including
an Attorney's fee of \$50. and expenses of Sale, which he will
receive in Cash, and pay to those entitled.) The Lands referred to
in the proceedings, described as containing 122 3/4 acres, More or less,
and adjoining the Lands of John S. Myrick, the North Carolina
State land, and others, and of which the said James Majell did
propose, that such Sale be made in auction, and in such parcels
as the said Comptroller may deem proper, and if a parcel of said
Lands should be for enough to satisfy the demands against said
James Majell then the Comptroller will only Sell that much
and no more; that the said Comptroller will advertise such
Sale at the Court House door and in least six other public places
in the Neighbor hood of the premises, and in one or more
Newspapers, for at least twenty days previous to such Sale, and
will make report of his proceedings to Court and return the
Points of the purchase with his Report. But no Sale shall be
made until this decree shall have expired of the present day
here, nor until the said George W. Dick as Comptroller agreed
shall execute before the Clerk of this Court in his official, a Bond
in the penalty of \$4000, payable to the Comptroller of the
District and Comptroller to execute faithfully this decree and
any other decree that he may be required to execute under
proceedings had in this cause.
