one hundred & fifty two  $6\frac{2}{10}$  dollars, with like interest  
to Thomas Ridley Son of N. T. Ridley Two hundred  
& ninety two  $\frac{17}{10}$  dollars with like interest, to James  
A. Sheafe Assignee of N. T. Harris, twenty eight  $\frac{85}{10}$   
dollars, with like interest, to M. Mansour Administrator of
