

The Court doth further adjudge order and decree that Mr. Goudwyn
 was to inform the Special Commissioner for that purpose of his
 receipt therefrom with due form from the papers of these Causes all of the
 Confederate State Bonds filed there with, except those in which
 were involved the amount then due to one Douchy to wit the sum of
 \$1300 and sell the same and make report to the Court. But the said
 Special Commissioner shall not fail to acknowledge this decree sooner
 he shall have first executed before the Clerk of this Court a bond with
 good security in the sum of five hundred dollars conditioned
 for the faithful performance of his duties as special Commissioner
 under this decree further herein that it may be entered in this cause
 respecting the said Confederate bonds to their proceeds. And the
 Court doth further adjudge order and decree that Mr. Shand
 trustee under the deed of trust execute & to him by Dally Neal be-
 ing date on Day of to secure the sum of \$7,800 and
 interest thereon payable to Mary Eliza Hoadley Kierland
 And Antonette Kierland do proceed after first advertisement the time
 and place of sale by Notice posted at Jerusalem and in the
 immediate vicinity of the said and in the Franklin Gazette
 for twenty days to sell at public auction at Jerusalem on
 Court Day the tract of land in the said deed
 mentioned to the highest bidder on the following terms to wit
 One third Cash, the balance a credit of one and two years to come
 from the purchase day with Adjourned security carrying
 interest from day of sale and that he out of the Cash pro-
 ceeds of sale pay the expenses of said sale and any unpaid
 taxes on said land and out of the balance pay to Mary
 Eliza Hoadley her portion of the debt secured and if then be
 any portion of the cash remaining be will deposit
 it for interest with the Marine Bank of Norfolk in his
 name as trustee subject to the further order of the Court to
 return the Certificate of deposit with his receipt of sale. But
 the purchaser may if he elects to do so, pay the whole of the
 purchase money in Cash and in the event the said
 trustee shall pay out of the net proceeds of sale to Mary Eliza
 Hoadley her proportion part of the debt secured and after
 deposit in the aforesaid Bank the proportion part of the debt
 which Joseph D Kierland and Antonette Kierland are entitled
 or have the same on real estate security secured by deed
 of Trust as a first lien in law assured at double the amount
 the loan and of good and undoubtless taking from the bor-
 rower bonds for the amount loaned payable to Joseph D
 Kierland and Antonette Kierland and he will pay the sur-
 plus of the proceeds remaining if any to the party or parties
 entitled to the equity of redemption on the aforesaid deed
 of trust and he will convey with special warranty by
 the said land unto the purchaser. The said Mr. Shand
 trustee will make report to the Court of his proceeding
 under this decree.
