

Application of Soldier, Sailor or Marine for Disability by Reason of Disease or the Infirmities of Age.

Geo. H. Barrett, do hereby apply for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and subsequent acts, as amended by an act approved March 10, 1908, entitled an act to aid the citizens of Virginia who were disabled by wounds received during the war between the States while serving as soldiers, sailors, or marines of Virginia, and such as served during the said war as soldiers, sailors, or marines of Virginia, who are now disabled by disease contracted during the war, or by the infirmities of age, and the widows of soldiers, sailors, or marines of Virginia, who lost their lives in said service, or whose death resulted from wounds received or disease contracted in said service, and providing penalties for violating the provisions of this act, and I do solemnly swear that I am a citizen of the State of Virginia, resident at *Hampton, Va., P. O. #2*, in the County of *Hampton*, in the said State, and that I have been an actual resident of the said State for two years, and of the said County (or county) for one year next preceding the date of this application, and that I was a soldier (sailor or marine) of the State of Virginia in the war between the United States and the Confederate States, as a member of (here state specifically the command and branch of the service to which the applicant belonged, and the names of his immediate superior officers) *18th Virginia Cavalry, Heavy Artillery, Major M. D. Harbin, Company A, U. S. Gaffin, Captain, N. R. Gaffin, 1st Lieutenant, Wm. H. Stevenson, Second Lieutenant,* and that I am now disabled by disease (here state the nature of the disease and the cause from which it resulted)

and that from the effects of such disease I am now permanently disabled from following my usual and ordinary occupation or any other occupation for a livelihood (in the case of disability from the infirmities of age, strike out all relating to disability by disease, and then proceed as follows:) and that I am now suffering from the infirmities of age, and permanently incapacitated thereby from following my usual and ordinary occupation, or any other occupation for a livelihood (here state specifically the nature and character of the disability which prevents the applicant from following any occupation for a livelihood)

Described by a Corp. by Resulting Chronic Ulcer, and that during the said war I was loyal and true to my duty, and never, at any time, deserted my command or voluntarily abandoned my post of duty in the said service, and that by reason of such disability I am now entitled to receive, under the said act the sum of *\$200* dollars annually. And I do further swear that I do not hold any national, State, city or county office, which pays me in salary or fees Two Hundred dollars per annum; nor have I an income from any other employment or any source whatever which amounts to Two Hundred dollars per annum; nor do I receive from any source whatever money or other means of support amounting in value to the sum of Two Hundred dollars per annum; nor do I own in my own right, nor does any one hold in trust for my benefit or use, nor does my wife own, nor does any one hold in trust for my wife, estate or property, either real, personal, or mixed, either in fee or for life, of the assessed value of *Eleven Hundred and Fifty dollars*; (But a soldier, sailor or marine who is entitled to be placed in Class A or B shall have the amount hereinbefore provided for him, unless he or his wife has an estate of the assessed value of one thousand dollars, but also that a soldier, sailor or marine who has reached the age of eighty years shall have the amount hereinbefore provided for him, unless he or his wife shall have an estate of the assessed value of fifteen hundred dollars: provided, that the actual amount due or unpaid upon any deed of trust or mortgage to secure the payment of a debt shall be deducted from the assessed value of the property of claimants under this act) nor do I receive any aid or pension from any other State, or from the United States, or from any other source, and that I am not an inmate of any soldiers' home, and I do further swear that the answers given to the following questions are true:

1. What is your age? Ans *67*
 2. Where were you born? Ans *Southampton County, Virginia*
 3. How long have you resided in Virginia? Ans *All of my life*
 4. How long have you resided in the city or county of your present residence? Ans *All of my life*
 5. What is your usual and ordinary occupation for earning a livelihood? Ans *Farming*
 6. How long have you followed such occupation or employment? Ans *All of my life*
 7. Have you followed such occupation or employment, or any other occupation or employment, within the last two years? If so, state when and where, and the amount of your annual income from the same? Ans *No, I have been unable to work*
 8. State specifically the nature of your disability or disease? Ans *Chronic ulcer of the leg, involving the bone,*
 9. What were the causes which led to the disease which has resulted in your disability? Ans *Old birth, resulting from a buried*
 10. How long have you suffered from such disease, and when did you first become aware that you were afflicted with the same? Ans *1870,*
 11. With what disease or sickness did you suffer during the time of your service? Ans *None*
 12. Are you totally disabled because of such disease, or the infirmities of age, from following your usual and ordinary occupation or employment, or any other occupation, or employment, by which to earn a livelihood? If not totally disabled thereby, but only partially, state the extent of your partial disability. Ans *Totally disabled from work*
 13. When and where did you enter the service of Virginia, or of the Confederate States? Ans *At Jerusalem on Southampton County in 1861*
 14. In what command and service were you engaged during the war between the States? Ans *Sixth Corps*
 15. How long were you in the service? Ans *1861-1865*
 16. When did you leave the service, and under what circumstances? Ans *At Surrender, at Sailor's Creek*
 17. If suffering from disease, state what physician or physicians have attended you for the same? Ans *Dr. C. A. deBordman, Brownsville, VA*
 18. Give the names and addresses of two or more in the service of your command, if any such be living, and if not, no state. Ans *Jas. N. Vaughan, Franklin, NC, Jas. G. Scott, Leesburg, GA, Dr. S. S. Sted, Concord, NC*
 19. Give here any other information you may possess relating to your service or disability, that will support the justice of your claim for aid. Ans *Coronavirus Service through the Civil War*
 20. Is there any camp of Confederate veterans in the city or county of your residence? Ans *Yes, Virginian Cavalry Camp, Franklin, NC*
 21. Is there any one living, the residence and address of whom is known to you, either command or otherwise, who has knowledge of your service, and of the cause of your disability? If so or not, state. Ans *Many men of my affiliation, but few know the cause*
