APPLICATION of a widow of a Soldier, Sailor, or Marine of the late late Confederacy under acts approved March 25, 1923 and March 10, 1928.

I, Alma L. Cobb, do hereby apply for a pension under the provisions of the acts of the General Assembly of Virginia relating to Confederate pensions.
I do solemnly swear that I am a citizen of the State of Virginia and that I have been an actual resident of the said State for two years next preceding the date of this application, and that I am the widow of Solomon C. Myrick, who was a soldier (sailor or marine) in the service of the Confederate States in the War Between the States, and that I was married to him before January 1, 1890 (See note below) and to the best of my knowledge and belief during the said war my husband was loyal and true to his duty, and never at any time deserted his command or voluntarily abandoned his post of duty in the time of his death, and that I am a widow at the date of making this application, and that I am now entitled to receive a pension under the provisions of said act. I do further swear that I do not hold a national, State or county office, which pays a salary or fee exceeding four hundred dollars (\$400.00) per annum, nor do I own in my own right, nor is there held in trust for my own benefit, estate or property, either real, personal or mixed in fee or for life, which yields a total income exceeding four hundred dollars (\$400.00) per annum, or which yields an income which, added to my income from all other sources, exceeds four hundred dollars (\$400.00) per annum. I do further swear that I do not receive a pension from this or any other State, nor do I receive necessary aid from any source, board and clothing excepted. I do solemnly swear that the answers given to the questions which I am required to answer in this application are true to the best of my knowledge and belief.

Any assessment of property does not affect the right to pension, but the gross income from all sources must not exceed \$400.00 per year. Certificates under B, C, E, not necessary if husband was pensioner.

NOTE—Widows seventy-five years old or over can receive pension regardless of date of marriage. Widows under seventy-five years old are required to have been married prior to January 1st, 1890.
