AFFIDAVIT OF COMRADES.

We, C. S. Stephens and W. T. Allen, do solemnly swear that we are residents of the County of Southampton, in the State of Virginia, and that James Doyle, whose name is signed to the annexed application for aid under the act of the General Assembly of Virginia, approved April 2, 1902, is personally well known to us, and that we have known him well for 14 years, and that we were soldiers (sailors or marines) in the military (or naval) service of Virginia, or of the Confederate States, during the war between the United States and the Confederate States, and that the said James Doyle who was also a soldier (sailor or marine) in the said service during the said war, was with us, members of (here state command and immediate superior officers thereof) 1st Regt. Va. Cavalry, 18th Division of Artillery and that the said James Doyle was a loyal and true soldier (sailor or marine) in the said service, and faithful in the discharge of his duties, and that we verily believe he is disabled from the service in the manner in his application stated, and that his claim is just, and that we have no personal interest in the allowance of his claim under the said act.

AFFIDAVIT OF WITNESSES, NOT COMRADES.

We, R. H. Rollins and R. J. Williams, do solemnly swear that we are residents of the County of Southampton, in the State of Virginia, and that we personally know, and are well acquainted with James Doyle, whose name is signed to the annexed application, and who is applying for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and that we have known the said applicant for 20 years, and that to our personal knowledge the said James Doyle was a loyal and true soldier (sailor or marine), in the military (or naval) service of Virginia, or of the Confederate States in the war between the States, and was faithful in the discharge of his duty, and that we verily believe he is disabled from the service, and in the manner in his application set forth, and that his claim is just, and that we have no personal interest in the allowance of his claim under the said act.

CERTIFICATE OF PHYSICIAN.

I, A. M. Adkins, a practicing physician in the County of Southampton, in the State of Virginia, do certify that I am personally acquainted with James Doyle, whose name is signed to the annexed application for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and that from a personal examination of the said James Doyle, as to the disability set forth in his application and the cause thereof, I am clearly of the opinion that he is disabled by reason of (here state specifically the nature of the disability and the cause thereof, and if such disability be total, whether the applicant is deprived thereby of all ability to pursue his usual and ordinary occupation for a livelihood, or any other occupation for a livelihood, and if the disability be partial, to what extent the applicant is hindered thereby from pursuing such occupation as aforesaid) I cannot say that Mr. Doyle is disabled from any definite disease or the cause of any disease, but perhaps during his age he may not feel as physically able to work as he has done in years past. I attended him about 3 years ago in a spell of sickness of Malarial type, but cannot conclusively assert that his disability is due to causes assigned in the said application, and that he is entitled to aid under the provisions of the said act, and that I have no personal interest in the allowance of the applicant's claim. CERTIFICATE OF CAMP OF CONFEDERATE VETERANS.
