Hancock, who was a soldier (sailor or marine) in the military (or naval) service of Virginia, or of the Confederate States, and that we were soldiers (sailors or marines) in the said service during the said war, and that we were, with the said James T. Hancock, members of (here state the command and the immediate superior officers thereof) Co. A. 1st Va. Cavalry, Capt. J. C. Clarke (sunderland, cotton), Camp and that to our personal knowledge, on or about the 13 day of December, 1862, at (here state battle or combat where killed or fatal wounds received) near Fort Fisher and that the said James T. Hancock during the said war (state here whether killed or died as the result of wounds received, or surgical operation therefor) died (if he died after the war, strike out all relating to death during the war and proceed as follows), on or about the 13 day of December, 1862, the said James T. Hancock died, and that the said James T. Hancock was a true and loyal soldier in the said service, and was faithful in the discharge of his duty as a soldier (sailor or marine) in the said service, and that we have no personal interest in the allowance of the applicant's claim.

Hancock, whose name is signed to the annexed application, and who is applying for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and that we have known the said applicant for 25 years, and that to our personal knowledge she is the widow of James T. Hancock, who was a loyal and true soldier (sailor or marine) in the military (or naval) service of Virginia, or of the Confederate States, in the war between the States, and that on or about the 13 day of December, 1862, at (here state battle or combat where killed or fatal wound received) near Fort Fisher the said James T. Hancock during the said war (state here whether killed or died as the result of wounds received, or surgical operation therefor) died (if he died after the war, strike out all relating to death during the war and proceed as follows), on or about the 13 day of December, 1862, the said James T. Hancock died, and that the said James T. Hancock lived as husband and wife up to the date of the death of the said James T. Hancock, and that we have no personal interest in the allowance of the applicant's claim.

CERTIFICATE OF PHYSICIAN.

I, P. H. Leach, a practicing physician in the County of Southampton, in the State of Virginia, do certify that I am personally acquainted with Virginia S. Hancock, whose name is signed to the annexed application for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and that I attended her husband, the said James T.
