

Application of Widow.

I, Caroline Johnson, do hereby apply for aid under the act of the General Assembly of Virginia, approved April 2, 1902, entitled an act to aid the citizens of Virginia who were disabled by wounds received during the war between the States while serving as soldiers, sailors, or marines of Virginia, and such as served during the said war as soldiers, sailors, or marines of Virginia, who are now disabled by disease contracted during the war, or by the infirmities of age, and the widows of soldiers, sailors, or marines of Virginia who lost their lives in said service, or whose death resulted from wounds received or disease contracted in said service, and providing penalties for violating the provisions of this act, and I do solemnly swear that I am a citizen of the State of Virginia resident at Southampton, in the County of Southampton, in the said State, and that I have been an actual resident of the said State for two years, and of the said city (or county) for one year next preceding the date of this application, and that I am the widow of Allen Johnson, who was a soldier (sailor or marine) in the service of the State of Virginia in the war between the States, and who was a member of (here state specifically the command and branch of the service to which the husband of the applicant belonged, and, if possible, the names of his immediate superior officers) Lt. J. Smithfield Co. 1st Regt. Va. Inf. Commanded by Capt. James H. Johnson War of the Rebellion Co. 1st and who, while in the discharge of his duty in the military or naval service of the State of Virginia, or of the Confederate States, during the said war, lost his life (if the husband of such widow was killed or died during the war as the result of wounds received, state the facts of the case as near as possible, giving the date of the husband's death) dropped died Oct. 12, 1891 (if the husband died after the war, strike out all relating to his death during the war, and then proceed as follows:), and who has since the said war died (here state specifically the cause of the death of the husband of the applicant and the date thereof) dropped died Oct. 12, 1891 and that, to the best of my knowledge, during the said war my said husband was loyal and true to his duty, and never, at any time, deserted his command or voluntarily abandoned his post of duty in the said service, and that I was never divorced from my said husband, and that I never voluntarily abandoned him during his life, but remained his true, faithful, and lawful wife up to the date of his death, and that I have never married since his death, and that I am now entitled to receive, under the said act, the sum of 25 dollars annually. And I do further swear that I do not hold any position or office, either national, State, city, or county, which pays me in salary or fees one hundred and fifty dollars per annum; nor have I an income from any other employment or other source whatever which amounts to one hundred and fifty dollars per annum; nor do I receive from any source whatever money or other means of support amounting in value to the sum of one hundred and fifty dollars per annum; nor do I own in my own right, nor does any one hold in trust for my benefit or use estate or property, either real, personal, or mixed, either in fee or for life, of the assessed value of five hundred dollars; nor do I receive any aid or pension from any other State, or from the United States, or from any other source, and that I am not an inmate of any public institution, and that I am without means of support, direct or indirect; and I do further swear that the answers given to the following questions are true:

1. What is your age? Ans. 43
2. Where were you born? Ans. Southampton Co. Va.
3. How long have you resided in Virginia? Ans. during life
4. How long have you resided in the city or county of your present residence? Ans. during life
5. What is your husband's full name? Ans. Allen Johnson
6. When and where were you married, and by whom? Ans. June 11, 1863, near Smithfield, by J. S. Jordan
7. When and where, as near as you can state, did your husband die, and from what cause? Ans. Oct. 12, 1891, dropped
8. Have you been married since the death of your said husband? Ans. no
9. Where and with whom do you now reside? Ans. near Smithfield, with Mrs. J. M. Heath
10. What property—real, personal or mixed—do you own? Ans. 48 acres of land, valued at \$1000, 1 bed, 1 board and 1 chair
11. What assistance do you receive, and what income have you from any source? Ans. nothing except help from friends
12. If your husband died since the war, please state where he died, and, if possible, the name and address of the attending physician? Ans. near Smithfield, by Dr. J. H. Dallas
13. Give the names and addresses, if possible, of two comrades in arms of your deceased husband. Ans. Lt. J. Smithfield Co. 1st Regt. Va. Inf. and Capt. James H. Johnson
14. Give the names and addresses of two persons who are familiar with the circumstances of your husband's death. Ans. J. H. Dallas and J. M. Heath
15. If your husband died since the war, please state whether his death resulted from wounds received in the war or from disease. Ans. disease
16. Give, as near as you can, the nature of the wound or the character of the disease from which your husband died. Ans. dropped
17. Give here any other information you may possess relating to the service of your husband or of his death that will support the justice of your claim for aid. Ans. he was honorably discharged owing to disease, and was not well again in life
18. Is there any camp of Confederate veterans in the city or county of your residence? Ans. yes
19. Is there any one living, the residence and address of whom is known to you, either comrade or otherwise, who has knowledge of your husband's service and of the cause of his death? If so or not, state. Ans. not that I know of
