

Application of Widow.

I, Mrs. Susanna Laine, do hereby apply for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and subsequent acts, as amended by an act approved March 10, 1904, entitled an act to aid the citizens of Virginia who were disabled by wounds received during the war between the States while serving as soldiers, sailors, or marines of Virginia, and such as served during the said war as soldiers, sailors, or marines of Virginia, who are now disabled by disease contracted during the war, or by the infirmities of age, and the widows of soldiers, sailors, or marines of Virginia who lost their lives in said service, or whose death resulted from wounds received or disease contracted in said service, and providing penalties for violating the provisions of this act, and I do solemnly swear that I am a citizen of the State of Virginia, resident at on Iron Berlin in Berlin District, in the Co. of Southampton, in the said State, and that I have been an actual resident of the said State for two years, and of the said city (or county) for one year next preceding the date of this application, and that I am the widow of James L. Laine, who was a soldier (sailor or marine) in the service of the State of Virginia in the war between the States, and who was a member of (here state specifically the command and branch of the service to which the husband of the applicant belonged, and, if possible, the names of his immediate superior officers) Third Virginia Regiment, Army of Northern Virginia, 1st Division, Company D, under Captain 1st Lt. Wood, and who, while in the discharge of his duty in the military or naval service of the State of Virginia, or of the Confederate States, during the said war, lost his life (if the husband of such widow was killed or died during the war as the result of wounds received, state the facts of the case as near as possible, giving the date of the husband's death) which death occurred on the 23rd day of May 1909 from Consumption of the bowels, and that, to the best of my knowledge, during the said war my husband was loyal and true to his duty, and never, at any time, deserted his command or voluntarily abandoned his post of duty in the said service, and that I was never divorced from my said husband, and that I never voluntarily abandoned him during his life, but remained his true, faithful, and lawful wife up to the date of his death, and that I am a widow at the date of making this application, and that I am now entitled to receive, under the said act the sum of Twenty-Five dollars annually. And I do further swear that I do not hold any position or office, either national, State, city or county, which pays me in salary or fee Two Hundred dollars per annum; nor have I an income from any other employment or other source whatever which amounts to Two Hundred dollars per annum; nor do I receive from any source whatever money or other means of support amounting in value to the sum of Two Hundred dollars per annum; nor do I own in my own right, nor does any one hold in trust for my benefit or use estate or property, either real, personal, or mixed, either in fee or for life, of the assessed value of Seven Hundred and Fifty dollars; nor do I receive any aid or pension from any other State, or from the United States, or from any other source, and that I am without means of support, direct or indirect; and I do further swear that the answers given to the following questions are true:

1. What is your age? Ans 63 years
2. Where were you born? Ans In Southampton Co. Va.
3. How long have you resided in Virginia? Ans all my life
4. How long have you resided in the city or county of your present residence? Ans all my life
5. What is your husband's full name? Ans James L. Laine
6. When and where were you married, and by whom? Ans 27th day of February 1867 in Southampton Co., Va. by Rev. Mr. Woodman
7. When and where, as near as you can state, did your husband die, and from what cause? Ans 23rd day of May 1909 in Southampton Co., Va. from Consumption of the bowels
8. Have you been married since the death of your said husband? Ans No
9. Where and with whom do you now reside? Ans In Southampton Co. Va. with my son
10. What property—real, personal or mixed—do you own? Ans \$ 1.10.00
11. What assistance do you receive, and what income have you from any source? Ans None at all
12. If your husband died since the war, please state where he died, and, if possible, the name and address of the attending physician? Ans In Berlin & Iron District Southampton Co. Va. had no Physician
13. Give the names and addresses, if possible, of two comrades in arms of your deceased husband. Ans Henry Williams, 1st Lt. U.S., George Williams, Courtland Va.
14. Give the names and addresses of two persons who are familiar with the circumstances of your husband's death. Ans John Mangum, Sedley Va. R.F.D. 1, A. H. Gardner, Sedley Va. R.F.D. 1
15. If your husband died since the war, please state whether his death resulted from wounds received in the war, or from what disease? Ans He was a faithful soldier, and was never physically able for work of the war as he was before
16. Give, as near as you can, the nature of the wound or the character of the disease from which your husband died. Ans It was a flesh wound in the hip, Consumption of the bowels, from which he suffered 12 months before death
17. Give here any other information you may possess relating to the service of your husband or of his death, that will support the justice of your claim for aid. Ans He was a faithful soldier, and was never physically able for work of the war as he was before
18. Is there any camp of Confederate veterans in the city or county of your residence? Ans No
19. Is there any one living, the residence and address of whom is known to you, either comrade or otherwise, who has knowledge of your husband's service and of the cause of his death? If so or not, state. Ans George T. Whigham, Sedley, R.F.D. 1, Va.
