Foy* of the County of *Southampton* in the State of *Virginia*, do solemnly swear that we personally know, and are well acquainted with whose name is signed to the annexed application, and who is applying for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and that we have known the said applicant for *thirty* years, and that to our personal knowledge she is the widow of *James D. CERTIFICATE OF PHYSICIAN.
