Travis during the said war (state here whether killed or died as the result of wounds received, or surgical operation therefor) (if he died after the war, strike out all relating to death during the war and proceed as follows), on or about the 25th day of September, 1863, the said B. J. Travis died, and that the said B. J. Travis was a true and loyal soldier in the said service, and was faithful in the discharge of his duty as a soldier (sailor or marine) in the said service, and that we have no personal interest in the allowance of the applicant's claim.

AFFIDAVIT OF WITNESSES, NOT COMRADES, AS TO WOUNDS.

We, Le E. Battle and R. W. Branch of the County Southampton in the State of Virginia, do solemnly swear that we personally know, and are well acquainted with B. J. Travis whose name is signed to the annexed application, and who is applying for aid under the act of the (General Assembly of Virginia, approved April 2, 1902, and subsequent acts, as amended by an act approved March 10, 1908, and that we have known the said applicant for 50 years, and that to our personal knowledge she is the widow of B. J. Travis who was a loyal and true soldier (sailor or marine) in the military (or naval) service of Virginia, or of the Confederate States, in the war between the States, and that on or about the 25th day of September, 1863, at (here state battle or combat where killed or fatal wound received) at (here state battle or combat where killed or fatal wound received) during the said war (state whether killed or died as the result of wounds received, or surgical operation therefor) (if he died after the war, strike out all relating to death during the war and proceed as follows), on or about the 25th day of September, 1863, the said B. J. Travis died, and that the said B. J. Travis lived as husband and wife up to the date of the death of the said B. J. Travis and that we have no personal interest in the allowance of the applicant's claim.

CERTIFICATE OF PHYSICIAN.

I, Dr. J. P. Gay, a practicing physician, in the County Southampton of Virginia, do certify that I am personally acquainted with B. J. Travis whose name is signed to the annexed application for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and subsequent acts, as amended by an act approved March 10, 1908, and that I attended her husband, the said B. J. Travis during his last illness, and that from my professional knowledge of the cause of his death, I verily believe that his death resulted from old age and that I have no personal interest in the allowance of the applicant's claim.

CERTIFICATE OF THE COMMISSIONER OF THE REVENUE.

I, A. F. Calhoun Commissioner of the revenue, in the County Southampton of Virginia, do certify that Margaret A. Travis or her trustees, whose name is signed to the annexed application for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and subsequent acts, as amended by an act approved March 10, 1908, is charged on the land and personal property books of the said County Southampton with estate, real, personal and mixed, of the assessed value of 100.
