Certificate of Time and Place of Marriage

I, John S. Hitchen, a minister of the Union Church, or religious order of that name, do certify that on the 12th day of January, 1882, at Southampton Co., Virginia, under authority of the above License, I joined together in the Holy State of Matrimony the persons named and described therein. I qualified and gave bond according to law authorizing me to celebrate the rites of marriage in the County (or City) of Southampton, State of Virginia.

The Minister or other person celebrating a marriage is required, within thirty (30) days thereafter, to return the License and Certificate of the Clerk and his witnesses of the time and place at which the marriage was celebrated to the Clerk who issued the License; failure to comply with these requirements of the law makes the Minister or other person celebrating the marriage liable to a fine of not less than ten nor more than twenty dollars for each offense (see Section 5074 of the Code of Virginia, as amended by Act approved February 14, 1910, Acts 1910, chapter 24, pages 36 and 37).
