

118 Westbrook v Westbrook. <sup>his</sup> report returned June 2, 1869, agreed and ordered that the suit for and the amount  
of sum of £85. 2. 11<sup>s</sup> with interest thereon from the  
1<sup>st</sup> day Jan 7 1869, <sup>not being</sup> deducted and from the time when the defendant left the plaintiff's service  
interest as appears to the plaintiff be added to the  
amount of £100 Westbrook sued.
