Preston Governor of N.H. his Successor in office - the said Winred in the sum of \$50 and his said Security in the sum of \$25 each to be levied of their respective goods & chattels, lands and Tenements & to the said Governor for the use of the comd. rendered. Yet upon this condition that if said Winred shall keep the peace & be of good behavior towards all the good citizens of this comd. for the space of 12 calendar months from this day then but none especially towards British Subjects of this comd. this recognizance to be void or else to remain in full force.
