

The court after hearing the testimony and all the circumstances of the case are unanimously of opinion that the prisoner is guilty of manslaughter and sentenced to the benefit of clergy - Therefore it is ordered that he be burnt in the hand and receive 20 lashes well laid on upon his bare back and that the Sheriff of this county do execution thereof and the same being done and performed and proclamation being made in the manner is and nothing further appearing or being alleged against the prisoner it is ordered that he be forthwith discharged from further prosecution in this behalf.
