the Shff of the County or sergeant of the Corporation in which the said slave may be
found is directed to take possession of him and hire him out until the further order of
the Court. The plff is not to have the benefit of this decree until he shall give bond
with good security in the Clerk's Office in the sum of \$100. & conditioned to pay the costs
the Court awards them &c.
