Ordered that Jacob Barnes & Alex. Myrick, or either of them being sworn for that purpose do settle an account of Rich<sup>d</sup> Jordan's account on Robert Gordon Esq and make report thereof to Court -

The Report of Simon Marfee transactions as guardian of Lydia Beale and the exceptions filed thereto by the said Marfee come on to be heard. Whereupon after hearing the parties the Court ~~adjudging~~ the said exceptions do the order that the said report be recommended to the Law. who made it for them to consider and report thereupon -

Robin A. Jones vs Jackson Curator of Cummings. Report an appeal from the Judgment of a Justice. The Judgment of the single Justice being seen and inspected, and the parties & their Attornies fully heard. It seems to the Court that there is no error in the said Judgment. Therefore it is considered by the Court that the Appellee recover against the appellant the sum of \$10.00 cent with <sup>expenses</sup> ~~interest~~ thereon at the rate of Ten per cent from the 19<sup>th</sup> day of February 1831 till paid and this cost by him in this behalf expended. to be levied of the goods and chattels of the said de<sup>r</sup> in the hands of the appt. de<sup>r</sup>.

The Court appointed to report what repairs are necessary to the Seal of this County this day made their report which is ordered to be recorded. And it is ordered that Lewis Trovart, Lem J. Nicholson and James Rochelle or any two of them do let to the lowest undertaker the repairs necessary to be done to the said Seal and that the said James Rochelle do purchase the necessary tools and bars for the use of the said Seal and the money so laid out by the said Rochelle to be repaid him out of the contingent money in the Sheriff's hands upon his account being proved by the Court.

Ordered that the account of Henry B. Maughan Tutor which was certified to the Auditor of public Accounts at the last Court. Amounting to \$86.46 Cent be again certified to the Auditor with this explanation that the Court allow the said Maughan one Shilling per diem for the support of the infant child mentioned in the said account. the Court believing that the infant was of too tender an age to be separated from its mother & that it was not entirely supported by its mother's <sup>bread</sup>.

Ordered that the Estate of Mary Halcome de<sup>r</sup> be committed to the hands of Clement Rochelle Sheriff of this County for a term.
