Therefore it is ordered that the said Benjamin Cobb be charged with the annual payment of \$10 for the space of six years from this day and that she pay the same to the Overseers of the Poor of this County at the end of each year for the said space of six years in case the said child shall live so long - And it is further ordered that the said Benj^r. Cobb be committed to the custody of the Sheriff of this County until he shall enter into a recognizance with two sufficient securities himself to be bound in the sum of \$60. and the said securities in the sum of \$30 each conditioned according to Law or until he shall be otherwise discharged by due course of Law - Whereupon the said Benj^r. Cobb here in Court subscribed & delivered in a Schedule of his Est. & made oath thereof according to Law. Ordered that he be discharged from custody if detained for no other cause.
