 ledge themselves indebted to John Floyd Governor of the Commonwealth of Virginia
 in that as to pay the said John Barnes, Benjamin Barnes, William Jones
 in the sum of One hundred dollars each and the said Pitt Thomas,
 Thomas Le Jones, Fulding & Mahone, Hardy Jones & Bolling, Clerk and the
 sum of twenty dollars each, ^{for each of the above named parties} to be made and levied of their respective goods &
 chattels land and tenements, and to the said Governor for the use of the Com-
 monwealth rendered. Yet upon this condition that if the said John Barnes
 Benjamin Barnes & William Jones do severally keep the peace and be of
 good behavior toward all the citizens of this Commonwealth for the space of
 twelve months from this day, then this recognizance to be void or else to
 remain in full force & effect.

 A. Sparte or any 3 of them let to the lowest undertaker the repairs of the bridge
 & cross at Stony Point at Jerusalem & make report of.
 Ordered that the Court be adjourned till the first day of the next Term.
