the annual payment of \$15. for the term of seven years. and that he pay the said

acknowledged themselves indebted to Littleton W Fagwell Governor of the Common-
wealth of Virginia the said Underwood in the sum of \$100 Dols. and the said
Richard Porter & Bommell Beale in the sum of \$50 Dols. each of their respec-
tive goods & chattels land & tenements to be levied and to the said Governor &
his Successor for the use of the Commonwealth rendered. Yet upon this condition that
if the said Edmund Underwood shall well & truly observe and perform the above
order of the Court made against him then the above recognizance to be void or else
to remain in full force & virtue.
