The Court after hearing the testimony discharge the said Charles Abbot to be the father of the said bastard child and that the said child is likely to become chargeable to this County. Therefore it is ordered that the said Charles Abbot be charged with the annual payment of \$15. and that he pay the same to the Overseer of the Poor of this County every year for the term of seven years from this day in case the said child should live so long. And the said Charles Abbot failing to give security for the payment of the said sum of money shall be committed to the custody of the Sheriff of this County to be confined in the common jail of the same until he shall give security by entering into recognizance in the sum of \$210 with sufficient security to abide the above order of the Court or be otherwise discharged by due course of Law.
