

- manner to such persons or persons as will undertake the construction thereof
 Pursuant to the Act of Assembly the Court doth order and direct that for the purpose of
 procuring the lands in this County, the same be divided into 39 parcels as follows. Count-
 to Hollings River and down the said river to the beginning.
- No 2 From the north side of the flat Swamp from the old Parish line thence to the head of
 and up that to the flat Swamp. and down the said flat Swamp.
 - No 3 Bounded by the Hollings River and the flat Swamp and from the old Parish line to the
 flat Swamp and so up to Thomas Creek.
 - 4 Between the Indian line Hollings river the 3 creeks. and the creek road.
 - 5 From the Anglica Swamp bridge up the Swamp to Thomas Branch up the 1st Branch
 to the Anglica Chappel then down Manor road to the head of Buckhorn down the
 road and by the said road to the beginning.
 - 6 From the mouth of Peckys branch to the head of Spruces Branch, down that to those
 meadow up that to Robins branch, up to the head of the Anglica Swamp. and down
 the said Swamp to the beginning.
 - 7 From Robins branch up the back side of the 3 creeks to the County line to McPherson River
 down the said river to the forks of the line & thence to Robins branch.
 - 8 From the former parish line down the flat Swamp to Craffords road. and along the 1st
 road to the County line, and up the said line to ^{the mouth of} Thomas branch, up that to the old parish
 line and along the said line to the beginning.
 - 9 From Craffords road down the flat Swamp to the County line to Craffords road
 along the said road to the beginning.
 - 10 From the mouth of Blounts Swamp to the mouth of Rice Swamp, up that to the Indian
 line down the said line to Craffords road up the said road to flat Swamp. and up the
 same to the beginning.
 - 11 From the parish line at the flat Swamp down the said Swamp to the mouth of
 Blounts Swamp up the Swamp to the mouth of Rice Swamp, up that to the Indian line
 along the 1st Branch to Thomas branch, down that to the Anglica Swamp and up that
 to the beginning head of the Robin Branch down the 1st Branch to the old parish line then
 to the beginning.
 - 12 From the old County line on the back side of the Cypress Swamp and up the Manor
 Boons road, up the said line to the County line down the same to the County line then to
 the beginning.
 - 13 From the County line at Boons road up the said line to the mouth of flat Swamp up
 that to Joseph Everetts thence along Taylors road to Whitebuds path, thence down the
 said path to Cypress Swamp, down the said Swamp to Boons road up the said road
 to the beginning.
 - 14 From Thomas Everetts, along Taylors road to Tuckers Swamp up the same to
 Craffords road up a said road to the flat Swamp and down the said Swamp to the
 beginning.
 - 15 From the mouth of the great branch up the said branch to the head, thence a line
 of the River Mr Barlows to the head of Blounts Swamp down the said Swamp to the
