Redmond Redgpath of this County who stands committed to the Court of this County charged with felony stealing taking and carrying away on the 11th day of February last three pieces of pork from the meat house of Drury Beale of the said County was this day set to the bar in custody of the jailer of this County. The Court remanded for his examination having first read and thereupon Drury Beale was sworn and examined and the prisoner by his counsel fully heard. The Court upon all the circumstances of the case arrived at opinion that the prisoner ought to be tried for the said supposed offence at the next Circuit Superior Court of Law & Chancery to be held for this County and therefore the prisoner is remanded to jail.

Be it remembered that Drury Beale has in Court solemnly pledged himself to be obedient & Subject to Wm. J. F. Governor of the Commonwealth of Virginia on the just and full sum of One thousand dollars of his goods & chattels lands and tenements to be levied and to the said Governor and his Successors for the use of the Commonwealth rendered. Yet upon this condition stating that said Drury Beale shall ~~bring this~~ personal appearance before the Judge of our Circuit Superior Court of Law & Chancery for this County on the first day of the next Term and give such evidence as he deems on behalf of the Commonwealth against Redmond Redgpath who stands charged with Stealing and shall not depart thence

The day being detained in custody for want of bond committed Court & adjourned judgment for the plaintiff for the sum of \$32.70 cents with interest from the 1st day of January 1855 till paid & C.
