

William M. Edwards is appointed Surveyor of the Road from the Cedar Spring to Hopewellville in the town of Abram & Harmon ex parte.

Whereupon for reasons appearing to the Court the said Everett Edwards is adjourned till to morrow. And thereupon his securities here in Court severally acknowledged themselves indebted to Wyndham Robertson Esq. Lieutenant Governor & acting as Governor of the Commonwealth of Virginia, that is to say the said Everett Edwards in the sum of One hundred dollars and the said securities in the sum of One hundred dollars each of their respective good & chattels lands and tenements to be levied and to the said Lieutenant Governor this Successor for the use of the Commonwealth rendered Yet upon this Condition that if the said Everett Edwards shall make his personal appearance before the Justice of the County Court of Southampton in the Court house on to morrow by Eleven O'clock A.M. to stand his trial for the offence of which he stands charged & shall not depart thence without leave of the Court then this recognizance to be void or else to remain in full force.

Abridgton Edwards of this County who stands charged with feloniously stealing taking & carrying away on the 7th of May 1836. from the stand of Wm. Mallory in the town of Jerusalem one orange, some candy & raisins of the value of ten cents. this day appears in Court in discharge of his recognizance (the Court summoned for his examination not having met) And thereupon for reasons appearing to the Court the said Abridgton Edwards is adjourned till to morrow. Whereupon the said Abridgton Edwards to gather with Richmond Edwards & Jonas Edwards. the securities here in Court severally acknowledged themselves to be indebted to Wyndham Robertson Esq. Lieutenant Governor & acting as Governor of the Commonwealth of Virginia, that is to say the said Abridgton Edwards in the sum of One hundred & twenty dollars & the said securities in the sum of \$10 each of their respective good & chattels lands & tenements to be levied and to the said Governor this Successor for the use of the Commonwealth rendered Yet upon this Condition that if the said Abridgton Edwards shall personally appear before the Commonwealths Justice of the Peace for this County at the Court house on the morning by Eleven O'clock to stand his trial for the offence of which he stands charged and shall not depart thence without leave of said Court then this recognizance to be void or else to remain in full force.

Thomas B. Morrell one of the Executors named in the will of Cherry Peale dec'd. qualified & gave bond Security according to Law. Peter Edwards the Exor. Esq. appeared in Court and refused to qualify.
