Therefore judgment is granted against the said Dft Ridley for the fine of one Cnt & Cts.

Commonwealth v Island - Rule 4. The rule made absolute & leave given the att. for the Com. to file an Inf. against the Dft. & process awarded to answer the same.

Commonwealth v Capps & Naughton. Rule 4. The rule made absolute leave given the att. for the Commonwealth to file an Inf. against the Dfts & process awarded to answer the same.

The rule made against Fielding & Mahone for not attending this day as a witness for the Commonwealth v Crumpler & Wilson is discharged.
