of her if any thing for herself she has or can pay why the Court should not now proceed to
pronounce judgment against her according to law and nothing being offered or alleged in
delay of judgment it is considered by the Court that the said Malinda be hanged by the neck

the body of her the said Malinda on the 20th day of March next between the hours of
