

Resolved that the Editors of the Richmond, Norfolk and Petersburg papers be furnished with a copy of these Resolutions and requested to publish them.

Pursuant to the Act of Assembly the Court doth order and direct that for the purpose of surveying the lands in the County the same be divided into 39 parcels as follows to wit:
 Parcel No. 1. From Nottingham river up the great Swamp to Craffords road, down said road to Nottingham River and down the said river to the beginning.

2. From the north side of the Flat Swamp from the old parish line, thence to the Colton branch and up that to the Angelica Swamp up the same to Robins branch and up that to the flat Swamp and down the said flat Swamp.

3. Bounded by the Meherrin River and the flat Swamp and from the old parish line to the flat Swamp and so up to Thomas Coocks.

4. Between Nottingham River, Rays bridge road, the three creeks and the half field road.

5. All the lands lying East of the Buckhorn Swamp, Nottingham River, the Indian line and the main road sometimes called the creek road.

6. From the Angelica Swamp bridge, up the swamp to Townsend branch, up the said branch to the Angelica Chappel, then down Darners road to the head of Buckhorn, down that is the new road and by the said road to the beginning.

7. From the mouth of Riddleys branch to the head of Georges branch, down that to Ross meadow, up that to Robins branch, up that to the head of the Angelica Swamp, and down the said Swamp to the beginning.

8. From Robins branch up the South side of the three creeks to the County line to the Meherrin river, down the said river to Thomas Coocks' land and thence to Robins branch.

9. From the former parish line down the flat Swamp to Craffords road and along the said road to the County line and up the said line to the Greenville line, up that to the old parish line and along the said line to the beginning.

10. From Craffords road down the flat Swamp to the County line to Craffords road, along the said road to the beginning.

11. From the mouth of Blants Swamp to the mouth of Ross Swamp, up that to the Indian line, down the said line to Craffords road, up the said road to flat Swamp and up the same to the beginning.

12. From the parish line at the flat Swamp, down the said Swamp to the mouth of Blants Swamp, up the same to the mouth of Ross Swamp, up that to the Indian line, up the said branch to Townsend branch, down that to the Angelica Swamp, and up that to the head of the Colton branch, down said branch to the old parish line, then to the beginning.

13. From the old County line on the South side of the Wyfords Swamp and up the same to Bonds road, along the said road to the County line, down the said line to the beginning.

14. From the County line at Bonds road up the said line to the mouth of flat Swamp, up that to Joseph Overalls, thence along Taylors road to Whiteheads path, thence down the said path to the Wyfords Swamp, down the S. Swamp to Bonds road up the said road to the beginning.
