Deed of bargains and sale from Thomas b Jones and Martha his wife Anthony N Williams and John A Turner Conveying a house and lot situated in and adjacent to the Town of Jerusalem and known as the Turner Lot formerly kept by the said Jones and the household and kitchen furnished belonging to the same was acknowledged in the Clerks Office on the 22<sup>d</sup> December 1840 by the said Thomas b Jones and together with the certificate of the acknowledgement of the wife admitted to Record.

Deed of Release between L R Edwards of the first part William G Cobrell of the second part and Thomas b Jones of the third part releasing several lots and parcels of land situated in the Town of Jerusalem viz parts of Lots No 17, 18, & 19 was acknowledged in the Clerks Office on the 22<sup>d</sup> December 1840 by the parties thereto and admitted to Record.

Deed of Release from James G French as trustee to Samuel Wallace releasing a tract of 105 acres of Land was acknowledged in the Clerks office on the 23<sup>d</sup> December 1840 by the said James G French and admitted to Record.

Deed of Trust between Samuel Wallace of the first part L R Edwards of the second part and James G French of the third part Conveying 105 acres of land was acknowledged in the Clerks office on the 23<sup>d</sup> December 1840 by the parties thereto and admitted to Record.

Agreement between Peter Cooper and Levi Waller by which the said Waller covenanted to support the said Cooper during his lifetime was proved in the Clerks office on the 21<sup>d</sup> December 1840 by two of the witnesses thereto and admitted to Record.

Deed of Trust between Anthony N Williams of John A Turner of the first part Samuel Jones of the second part and Samuel T Jones of the third part Conveying three negroes David, Harry and Margaret the property of Anthony N Williams and three little boys Martin and Phil the property of John A Turner was acknowledged in the Clerks office on the 25<sup>d</sup> December 1840 by those of the parties thereto and admitted to Record.

Deed of bargains and sale from Thomas b Jones and Martha his wife to Anna N Gillill Conveying a tract of One acre of land was acknowledged in the Clerks Office on the 31<sup>d</sup> December 1840 by Thomas b Jones and admitted to Record.

Deed of bargains and sale from Thomas b Jones and Martha his wife to Fitchings Jackson Conveying a certain part of a certain lot in the Town of Jerusalem designated as Lot No 10 also another lot or piece of land adjoining the same was acknowledged in the Clerks Office on the 4<sup>th</sup> January 1841 by Thomas b Jones and together with the certificate of the party examining and acknowledging of the wife admitted to Record.

Deed of trust between Anthony N Williams and John A Turner of the first part L R Edwards of the second part and Thomas b Jones of the third part Conveying a certain lot and piece of land situated in and adjacent to the Town of Jerusalem and Twenty beds and the balance of the household and kitchen furniture belonging to the said lot was acknowledged in the Clerks office on the 14<sup>th</sup> day of January 1841 by the parties thereto and admitted to Record.

Laws Spec. v. Applewhites now qd.
