Certificate is granted him for obtaining letters of administration on the estate of the said James Scott dec^d with his said will annexed in due form.

Thomas Johnson with A B Urquhart Thomas L Jones Joseph L Bessie & Colgate Johnson John Doyles & Carlton Mott his securities have in Court severally acknowledged themselves indebted unto Thomas W Gilmer ex Governor of the Commonwealth of Virginia the said Governor in the sum of One hundred dollars and his said securities in the sum of \$20.00 to each of them respectively goods & chattels land & tenements to be seized and taken said Governor this prescription for the use of the Commonwealth rendered. Yet upon this condition that if the said Thomas Johnson shall keep the peace & be of good behavior towards all the Citizens of this Commonwealth more especially towards John F Holland & William Norvell for the space of twelve months from the day when the above recognizance is to be void or else to remain in full force.

Ordered that Tuleah B Edwards who is barely app^d Com for the purpose State sell & adjust Selas Summell's estate in Charles W Goodenough's estate & make report to the Court. Ordered that the Poor and Madson Margaret & Brannan children of Aron McLean free negroes be Polley Brindle according to Law ^{per annum} covenanting with the said Polley Brindle that she pay to the mother of 5 children the sum of \$1.00 for each child except the last year's apprenticeship the sums are to be paid to 5 said apprentices respectively.

Samuel T James appointed Constable in the Upper district of Pottomay Parish in this County rule July Court 1842 & thereupon he gave bond with security & took the oath required by Law which bond was act^d & O'Reevid. It appearing to the Court that the said James is a man of honesty & probity & good demeanor.
