Deed of trust between Samuel B Hines of the first part Leticia R Edwards and Thomas P Hobson of the second part and Martha and John M Rochelle and others of the third part conveying land negroes and all his the said Hines Estate of every kind and description was acknowledged in the Clerk's office on the 12th day of August 1842 by Hines and Edwards two of the parties thereto and submitted to Record.

Deed of trust between Miles E Lawrence of the first part William M Wright of the second part and John B Lawrence of the third part conveying lands and his the said Miles E Lawrence's interest in certain slaves was proved in the office on the 16th day of August 1842 by three of the subscribing witnesses thereto and submitted to Record.
