

Ordered that John Wigham or Bartholomew Brown & James P Jones or any 2 of them with the Commissions appointed by the County Court of Isle of Wight let in the lowest undertaker the repairs of rebuilding Parville bridge & cause the same when completed & make report &c

Ordered that James Cleaves William A Stephens & Allen Edwards or any 2 of them do with Commissions appointed by the County Court of Isle of Wight let in the lowest undertaker the repairs or rebuilding of Old Black water bridge near the same when completed & make report &c

Ordered that John Williams, John D Johnson & James Edwards or any 2 of them let in the lowest undertaker the repairs or rebuilding of the Franklin Bridge over Black water river & cause the same when completed & make report &c

Ordered that Eli Loker, Alexander Loker & John Loker do make out the said report of the Searchers in due way

Ordered that the Sheriff pay to Thomas B Williams the sum he is for loan & June last for repairs to the Court bridge

On motion of David Drew & William Prince against David Newson's son Martha Newson se for County security - The Summons awarded at the last Term being returned executed and the said Newson not appearing It is ordered that the said David Newson give the said Drew & Prince good County security the bond for which purpose is to be made the penalty of the bond awarded by the said David Newson as above: as approved and Conditioned according to them and the said David Newson failing to give the said bond & security it is ordered that the process & duties of the said David Newson as above as approved be notified & executed.

For reasons appearing to the Court. Ordered that the Poor bond New Seaborn - an orphan free goes to Samuel P Jones according to Law - that the said James pay annually to the Poor the sum of ten dollars during the apprenticeship of the said

New Seaborn - except for the last year which is to be paid to his apprentices -
