The last Will and Testament of deceased

Francis J. Ridley, Benjamin E. Pope, Mark T. Riddle, Jacob
Barrett - Henry Blow, Thomas B. McConnell, William L. Hood,
John Vick, Robert G. Griffin, James C. Bryant, George A. W. Newsom
and James W. Murfee having received the largest vote, are
hereby recommended to the Executive to be commissioned as
Justices of the Peace for this County.

On motion of Harrison C. Moore, Guardian of Eliza, Jane
Nancy and Catharine Bryant, ordered that he be accounted to
effect of the principles of Eliza and Jane of \$30 each - and of \$15
out of each of Nancy and Catharine's Estate and that he
account for the same in his actions hereafter to be made.

The Last Will and Testament of Wells Murfee deceased, was
proved by the oath of Jordan Edwards and William H. Edwards
and affirmation of William Peck three of the subscribing
witnesses thereto and ordered to be recorded - and on the motion
of James C. Mafurburg one of the Executors therein named, who
made oath thereto entered into bond with security, and did swear
according to Law, Certificate is granted him for obtaining a
probate thereof in due form - Silently being sworn to the other
Executor to qualify when he shall think fit.

The Last will and Testament of Nancy, Jacob etc² was
proved by the oath of Henry Mason a witness thereto, and
lodged for further prob.
