Deed of Trust between Martha O. Beale of the first part James M. Agut of the second part and John Barrett & Henry Simonds of the third part conveying her dower interest in the house of land on which she now lives, one negro girl, feather beds & other personal property was proved in the Clerk's Office on the 11<sup>th</sup> day of October 1842 by one of the witnesses and before proved by two other witnesses thence and admitted to Record.  
Deed of Trust between Warden Scheller of the first part Littleton R. Edwards of the second part and Joseph C. Muddaugh of the third part conveying land & hogs was proved in the Clerk's Office the 17<sup>th</sup> day of October 1842 by one of the witnesses and having been before proved by two other witnesses was admitted to Record.

Deed of Bargain and Sale from John Pick & wife to Jeremiah Cobb conveying land was proved in the Clerk's Office the 17<sup>th</sup> day of September 1842 by one of the witnesses thence and in the Clerk's Office the 17<sup>th</sup> day of October 1842 was acknowledged by John Pick a party thence & together with the certificate of the jury examination and acknowledgment of the wife admitted to Record.

Deed of Bargain & Sale from Joseph A. Edson to Emma Beale conveying his interest in a certain tract of land called & known by the name of the Marshfield land was acknowledged in the Clerk's Office the 17<sup>th</sup> day of October 1842 by the said J<sup>r</sup> A. Edson & admitted to Record.

Deed of Trust between William T. Cotton of the first part James A. McBlane of the second part and William Malloy & Jas. C. Peters of the third part conveying two negro men horses cattle hogs & other personal property was acknowledged in the Clerk's Office the 17<sup>th</sup> day of October 1842 by the said William T. Cotton a party thence and admitted to Record.

Deed of Bargain & Sale from James Drury & wife to Isaac Coffey conveying land & coal was acknowledged in the Clerk's Office the 17<sup>th</sup> day of October 1842 by James Drury a party thence and together with the certificate of the jury examination and acknowledgment of the wife admitted to Record.

Deed of Bargain & Sale from James H. Love to Matthew Williams conveying land was acknowledged in the Clerk's Office the 17<sup>th</sup> day of October 1842 by the said Jas. H. Love & admitted to Record.

Deed of Release from Jonathan B. Griffin and Jacob Barnes to Benjamin Barnes releasing land was acknowledged in the Clerk's Office the 17<sup>th</sup> day of October 1842 by the said Griffin & Barnes and admitted to Record.

Deed of Trust between Nathanael Whitfield of the first part Jonathan B. Griffin of the second part and Bennett Barrett of the third part conveying horse, carriage, harness & other personal property was acknowledged in the Clerk's Office the 17<sup>th</sup> day of October 1842 by all the parties thence and admitted to Record.

Deed of Trust between Robert Marshall of the first part William A. Jones of the second part & Joseph T. Clark of the third part conveying land & cattle & other personal property was proved in the Clerk's Office the 17<sup>th</sup> day of October 1842 by the witnesses as to two of the parties thence & was acknowledged by the other party thence and admitted to Record.

Deed of Trust between John Warren of the first part William R. Stephenson of the second part and Allen Stephenson of the third part conveying horse, cattle, cart wheels & other personal property was proved in the Clerk's Office the 17<sup>th</sup> day of October 1842 by the witnesses thence & admitted to Record.
