land was acknowledged in the Office on the 19th day of June 1843 by said Moore
and admitted to Record.

Deed of bargain and sale from Elizabeth Williams to James Holmes conveying land
was found in the Office on the 19th day of June 1843 by the oath of Patrick Rose
Exum Farmer and Matthew Harris the artificer trustee & admitted to Record.
Deed of bargain and sale from William D. Phillips and wife to William L. Rochelle
conveying land was acknowledged in the Office the 19th day of June 1843 by said Phillips
a party trustee and together with the certificate of the party examination & acknowl-
edgment of the wife admitted to Record.

Deed of bargain and sale from Edwards Butts Arthur A. Drury John Vick & wife
and Amos P. Drury to William J. Estelle conveying a Water Mill Mill & land
attached thereto, was acknowledged in the Office on the 19th day of June 1843 by
Edwards Butts & Arthur A. Drury two of the parties trustees and was proven by the
oath of Benjamin Griffin Robert G. Griffin & William A. Bell the artificer trustee
and John Vick & A. S. Drury two other parties trustees and together with the
certificate of the party examination & acknowledgement of the wife admitted to Record.

Deed of bargain and sale from Sam'l Nason trustee and James Jane and wife to
Mast'r James carrying land was found in the Office on the 20th day of
February 1843 by the oath of Edward P. Turner a witness trustee. And in the
Office on the 19th day of June 1843 the said Deed was proven by the oath of Mr
Coronot & Joseph T. Leland the other artificer trustee & together with the cer-
tificate of the party examination & acknowledgement of the wife admitted to Record.
Deed of bargain and sale from Sarah Turner to John B. Thorneal conveying her interest
in a certain tract of land was proven in the Office on the 19th day of June 1843
by the oath of N. J. Williams N. B. Bryant & Dawson Bank the artificer trustee.
