It appearing to the Court that the defendants have had legal notice of their actions they were
lawfully called but came not. Therefore Judgment is given in pliffs against the Dfcls. for the
Worthys of the said land with costs which judgments are to be discharged by the payment of
the principal sum due by said land with interest from their respective date with costs.

Ordered that the O'Pos or any 3 of them do go to the court undertaken (after giving due
notice thereof) the building of a house at the poor house 30 feet long by 16 feet wide and
8 feet pitched with a stack of Chimneys near the same when completed make report thereof
to the court.

On the motion of Davis Bryant who produced credentials of his ordination and of his long
in regular communion with the Methodist Protestant Church and who stated his bond with
poorly and of his long service thereto - Davis Bryant took the oath of Fidelity to the Commonwealth
which Testimonials are granted him in due form &c.

Anthony M. Howell who is charged on oath by Harry Warren a free negro son of the
county with being the father of his bastard child this day appeared in Court in discharge of his recognizance and therewith the said - Harry Warren and Bunting witnesses were sworn and deposed
and the said Howell by his counsel fully heard the Court after hearing the testimony and
from all the circumstances of the case are of opinion and do therefore adjudge the said Anthony M.
Howell to be the father of the said bastard child and that the said child is likely to become chargeable
to the County. Wherefore it is ordered that the said Anthony M. Howell be charged with an
annual payment of \$20. for the space of seven years from the birth of the said Child except
the 18 day of February 1743. and that he pay the same annually from thence 18 day of February
1743 to the full term of seven years in case the said Child shall live so long. Whereas the
said Anthony M. Howell with Harry Warren & others will
his descendants hereon Court lawfully acknowledge themselves indebted unto the Commonwealth of
Virginia that is to say the said Howell is the sum of \$140. and the said Harry Warren &
John Cobb - in the sum of \$70 each to be levied of their respective goods & chattels lands &
tenements &c the use of the said Commonwealth and soe. Yet upon this Condition that of the
said Anthony M. Howell shall come & present the order of the Court abovesigned against
him that the above recouerance to be void or else to remain in full force & virtue.
