Ordered that Robert G'Griffon the present guardian of said orphans pay unto said John Vick the sum of \$346.02 with interest from 31<sup>st</sup> Decemr 1842 the amount due from Caroline Vick - the sum of \$136.25 Conf. with Interest from 31<sup>st</sup> December 1842 the amount due from John T'Vick, and the sum of \$71.34, less <sup>with interest from 31<sup>st</sup> December 1842</sup> the amount due from Virginia Vick of sufficient fund he has in hand belonging to his ward if not that the said Griffon guardians as aforesaid make sale of such of the slaves of his ward as can be best spared for the purpose of paying the said amounts as well as such sum as may be due at the end of this year for their board & other necessities.

On the motion of Nathaniel Jones & John Whithead Curators for Anthony Hens for his admision. James Hens et al. Ordered that the said Anthony Hens be permitted to the next Court to give the said Nathaniel Jones & John Whithead guardians security according to law.

On motion of Benjamin D'Orus. Ordered that William D'Hoer who is appointed Special Commissioner for the purpose state each & adjust an account of the said D'Orus land possessed by Mr. Harris Holloman who shall make report & The court unanimously appoint John All Guler Commissioner of the Revenue on 3<sup>d</sup> day of Nov 1843 to receive in all moneys in the hands of Nathaniel Jones in the County for the year
