Ordered that James D. Broughton, Benjamin Story & Elizabeth Adams being sworn & do approve all the personal estate of John Seabrooke dec^d & return the same &c.

On motion of Benjamin Dawney sworn & John Seabrooke dec^d. Ordered that James D. Broughton, Benjamin Story & Elizabeth Adams be appointed by a competent sum of receiving, laying off & apportioning among the heirs & Martha Robinson their parts of land as directed by the will of the said John Seabrooke & make report to the Court.

On motion of Joseph H. Bingham Ordered the estate of Benjamin Bumpkin be committed to the hands of William L. Everett Esq. of the County for Stewardship according to Law.

On motion of Josiah Darden - Ordered that William Jones do state settle & adjust and account of said Darden's guardianship of Robert Doyal & make report &c.

On motion of Davis Barnett - Ordered that of commission of the Court do state settle & adjust and account of said Barnett's guardianship of the children of John & Sarah Barnett & report &c.

The last Will & Testament of Polly Barnett dec^d was proved by the oath of Charles Barnett a subscribing witness thereto.

On motion of Jonathan Darden - Ordered that he be exempt from the payment of taxes &c. for his negro Wills in future he being aged & infirm.

On motion of Thomas B. Worrell who made oath & gave bond & security according to Law certificate is granted him for Stewardship of the estate of James Story dec^d in due form.

Ordered that John C. Beale, Richard Darden, Robert P. Brown & Clement Beale or any 3 of them being sworn & do approve all the personal estate of James Story dec^d & make report &c.

Wm. & Wm. &c. Esq. The Court is directed that they make report.

On motion of Edwin Harrison Esq. sworn that he is bound in this Court as security for Edwin Daugherty, guardian of the person of Robert Smith dec^d & that the same amount to the sum of \$1000 damages by reason thereof & praying the Court for relief. Ordered that the said Daugherty be committed to the next Court to be given and Harrison enter security according to Law.
