The Court being of opinion that the lands in this County ought to be partitioned with there-  
fore order and direct that the County be divided into 3 of precincts as follow-

Precinct No. 1 From Notchay River up the great swamp to Grafford's road, down said road to  
Notchay river and down the said river to the beginning.

No. 2 From the north side of the flat swamp front the old parish line, thence to the Lebin  
branch and up that to the Angelica swamp, up the same to Robins branch and up that to the  
flat swamp and down the flat swamp.

3 Bounded by the Notchay river and the flat swamp and from the old parish line to the  
flat swamp and so up to Thomas Brooks.

4 Between Notchay river, Garry bridge road, the three creeks and the Belfield roads.

5 All the lands lying east of the Buckhorn swamp, Notchay river, the Indian line and  
the main road sometimes called the creek roads.

6 From the Angelica swamp bridge, up the swamp to Townsend branch, up the said  
branch to the Angelica branch, then down Warren's road to the head of Buckhorn,  
down that to the new road, and by the said road to the beginning.

7 From the mouth of Riddings branch to the head of George's branch, down that to  
Ross meadow, up that to Robins branch, up that to the head of the Angelica swamp  
and down the said swamp to the beginning.

8 From Robins branch up the south side of the stream back to the County line to the Notch-  
ay river. down the said river to Thomas Brooks land and thence to Robins branch.

9 From the former parish line down the flat swamp to Grafford's road and along the  
said road to the County line, and up the said road to the Bransville line, up that to the  
old parish line and along the said line to the beginning.

10 From Grafford road down the flat swamp to the County line. To Grafford road  
along the said road to the beginning.

11 From the mouth of Blunt's branch to the mouth of Ross' swamp, up that to the Indian  
line, down the said line to Grafford road, up the said road to Flat swamp and up  
the same to the beginning.

12 From the parish line at the flat swamp, down the said swamp to the mouth of  
Blunt's branch, up the same to the mouth of Ross' swamp, up that to the Indian line  
along the said branch to Townsend branch down that to the Angelica swamp, and up that  
to the head of the Lebin branch, down said branch to the old parish line, then to the  
beginning.

13 From the old County line on the south side of the Lopoff swamp and up the said  
to Poons road, along the said road to the County line, down the said road to the County line  
then to the beginning.

14 From the County line at Poons road up the said road to the mouth of flat swamp  
up that Joseph's branch, thence along Taylor's road to Whitchurch's pasture, thence down the  
said path to the Lopoff swamp down the said swamp to Poons road, up the said road  
to the beginning.
