The Court being of opinion that the lands in this County ought to be partitioned doth therefore order and direct that the County be divided into 3d. precincts as follow.

- Precinct No. 1 From Atchway River up the great swamp to Craffords road, down said road to Atchway river and down the said river to the beginning.
- No. 2 From the north side of the flat swamp from the old parish line, thence to the Cabin branch and up that to the Angelica swamp, up the same to Robin branch and up that to the flat swamp and down the flat swamp.
- No. 3 Bounded by the Meherrin river and the flat swamp and from the old parish line to the flat swamp and so up to Thomas Creek.
- No. 4 Between Atchway river George bridge road, the three creeks and the Wolfcreek road.
- No. 5 All the lands lying east of the Backhouse swamp, Atchway river, the indians line and the swan road formerly called the creek road.
- No. 6 From the Angelica swamp bridge, up the swamp to Townsend branch, up the said branch to the Angelica branch, then down Barrens road to the head of Backhouse, down that to the new road, and by the said road to the beginning.
- No. 7 From the mouth of Reddys branch to the head of Georges branch, down that to Ross meadow, up that to Robin branch, up that to the head of the Angelica swamp and down the said swamp to the beginning.
- No. 8 From Robin branch up the south side of the three creeks to the County line to the Meherrin river, down the said river to Thomas Creek land and thence to Robin branch.
- No. 9 From the former parish line down the flat swamp to Craffords road and along the said road to the County line, and up the said line to the Brownsville line, up that to the old parish line and along the said line to the beginning.
- No. 10 From Crafford road down the flat swamp to the County line, to Craffords road along the said road to the beginning.
- No. 11 From the mouth of Platts swamp to the mouth of Ross swamp, up that to the Indians line, down the said line to Craffords road, up the said road to flat swamp and up the same to the beginning.
- No. 12 From the parish line at the flat swamp, down the said swamp to the mouth of Platts swamp, up the same to the mouth of Ross swamp, up that to the meadow line along the said branch to Townsend branch, down that to the Angelica swamp, and up that to the head of the Cabin branch, down said branch to the old parish line, thence to the beginning.
- No. 13 From the old County line on the south side of the Cypress swamp and up the same to Boons road, along the said road to the County line, down the said line to the County line thence to the beginning.
- No. 14 From the County line at Boons road up the said road to the mouth of flat swamp up that Joseph Cornells, thence along Taylors road to Whiteheads path, thence down the said path to the Cypress swamp, down the said swamp to Boons road, up the said road to the beginning.
