

- N^o. 15 From Junior Crocks along Taylor's road to Turkeyhammer Swamp, up the swamp to the flat swamp and down the said swamp to the beginning.
- 16 From the mouth of the great branch, up the said branch to the head, thence along the line of the Rev^d Mr. Soley to the head of Dicks Swamp, then down the said branch to the river up the said river to the mouth of Turkeyhammer Swamp, up the said branch to the beginning.
- 17 From the mouth of Kidley's branch to the head of Georges branch, down said branch to the three creeks to the mouth of the Angelica Swamp, up the same to the beginning.
- 18 From the mouth of the three creeks, up the same to the mouth of the Hornet Swamp, up the same to the County line, down that to Nottoway River and down the said river to the beginning.
- 19 From the mouth of the Hornet Swamp, up the same to the County line, up said line to the poplar Swamp, down the said Swamp to the three creeks and down the creeks to the beginning.
- 20 From the mouth of the poplar Swamp, up the same to the County line, up the said line to the three creeks and down the three creeks to the beginning.
- 21 From the buckhorn bridge up the Swamp to the old Indian line, along said line to Buckhorn road, up the said road to the beginning.
- 22 From Mandalls on the great road at the flat Swamp, down the said Swamp to the mouth of Coxes Swamp, up the said Swamp to the road up said road to the beginning.
- 23 From the Nottoway river, North Carolina line to the old Ansonville line.
- 24 Bounded by the old Ansonville line, between Black water and Nottoway river.
- 25 From the lands lying on the East side of Dr. Brown's road, bounding on the old Ansonville line thence up the Black Blatter to David Johnson's thence up the former side to the upper end road.
- 26 From all the lands of David Johnson on Black water river, up the Cypress Swamp to the road and down the road to the former line.
- 27 From all the lands on the West side of Dr. Brown's road and up Nottoway Swamp to the old parish line, along the said line to the Cypress Swamp and down the same to the road.
- 28 Between Nottoway Swamp, Nottoway river and the old parish line.
- 29 All the lands between water, Black creek and the Cypress Swamp.
- 30 All the lands from the former parish line between Black water and bridge to French bridge down Black creek to Black water.
- 31 From the old parish line to Broad water road and down the said road to Round hill Swamp, down the same to the beginning.
- 32 From the broad road up Swicks to the County line and thence to Black water and down Black water to the said road.
- 33 Between Round hill, the lightwood of the County line.
- 34 Between round hill, Black creek, the Appamunock and the County line.
- 35 Between the Appamunock, Nottoway River, and the County line.
- 36 From the former parish line, thence to the head of Black creek, thence up said creek and down the Swamp to Nottoway river, down said river to the former parish line.
- 37 Between Black Blatter and Broad water road.
- 38 Beginning at the mouth of Dicks Swamp, up that same road, along same road to the Cypress Swamp, down that to Nottoway River up that to the beginning.
- 39 The lands between Black lightwood of the County line - and
