James Adams, William Edwards & Walter Saunders overseers of the poor in the
 lower district of Pelukes parish in this County for the next ensuing three years
 And it is ordered that they be summoned to this next Court to qualify.

Fitzhugh v. Fitzhugh Lohy. For reason appearing to the Court Ordered
 that Samuel Braham & Braham Wm. & Thomas Wm. be added to the lower
 heretofore appointed to divide the land of Thomas Fitzhugh dec. & that they or
 any two of them make report to the Court.
