This Court proceeded as a Court of Oyer and Terminer for the trial of
Atimipa Ales at Sheriff's Office of this County ^{charge} with having maliciously inflicted
a blow at a Negro man slave named Anna the property of Williams & Son
of said County with the use of an axe with intent to kill and
murder him the said Anna was again sent to the jail in custody of the Jailor
of this County and being there of dangerous person not easily and
prisoner by the Court fully heard the Court after hearing the testimony
advised and all the circumstances considered: are of opinion that the prisoner
is guilty of the offence for which she stands charged. And therefore it being
demanded of the prisoner if any thing ⁱⁿ her behalf she had or knew to say
why the Court should not now proceed to pronounce judgment against her: and
nothing being offered ^{or alleged} in delay of judgment: it is considered by the
Court that the said Atimipa Ales be imprisoned in the public jail and
penitentiary house of the Commonwealth for the term of one year and it
is ordered that the Sheriff of this County do as soon as possible after the
adjournment of this Court remove and safely convey the said Atimipa Ales
from the jail of this County to the said public jail and penitentiary house
therein to be kept imprisoned and treated in the manner prescribed by Law
and the Court doth certify that on the trial of the said Atimipa Ales
nothing appeared to the Court either in aggravation or extenuation of the offence
of the said Atimipa Ales: nor did it appear that before the Commission of
the said offence she was of good or bad character or that by her have been
convicted or tried for any felony or other infamous crime: and therefore
she is remanded to jail.

And the Court doth certify that on the trial of the said Atimipa Ales
nothing appeared to the Court either in aggravation or extenuation of the offence
of the said Atimipa Ales: nor did it appear that before the Commission of
the said offence she was of good or bad character or that by her have been
