

- the said Road to the County line, and up the said line to the Greenville line up that to the old parish line and along the said line to the beginning;
- " 10: From Craffords road down the flat swamp to the County line, to Craffords road along the said Road to the beginning;
- " 11: From the mouth of Blunts swamp to the mouth of Roars swamp; up that to the Indian line; down the said line, to Craffords Road; up the said Road to flat swamp and up the same to the beginning;
- " 12: From the parish line at the flat swamp down the said swamp to the mouth of Blunts swamp, up the same to the mouth of Roars swamp, up that to the Indian line, along the said branch to Townsend branch, down that to the Anglin's swamp; and up that to the head of the Oak branch, down said branch to the old parish line then to the beginning;
- " 13: From the County line at the south side of the Cypress swamp, and up the same, to Boons road; along the said Road to the County line; down the said line to the County line then to the beginning;
- " 14: From the County line at Boons Road up the said Road to the mouth of flat swamp, up that Joseph Overalls, thence along Taylors Road to White heads path, thence down the said path to the Cypress swamp; down the said swamp to Boons road, up the said road to the beginning;
- " 15: From Simon Overalls along Taylors Road to Suchwa hunter swamp, up the said swamp, to Craffords Road; up said Road to the flat swamp, and down the said swamp, to the beginning;
- " 16: From the mouth of the great branch, up the said branch to the head; thence along the line of the River into Turkey to the head of Dick's swamp; then down the said swamp, to the river; up the said River to the mouth of Suchwa hunter swamp; up the said swamp to the beginning;
- " 17: From the mouth of Ridgway branch to the head of George branch; down said branch to Roars meadow, up that to Robins branch, down said branch to the three creeks, down the three creeks to the mouth of the Anglin's swamp; up the same to the beginning;
- " 18: From the mouth of the three creeks up the same to the mouth of the great swamp up the same to the County line down that to Kollaway River and down the said River to the beginning;
- " 19: From the mouth of the lower swamp, up the same to the County line up said line the poplar swamp; down the said swamp to the three creeks; and down the three creeks to the beginning;
- " 20: From the mouth of the poplar swamp; up the same to the County line, up the said line to the three creeks, and down the three creeks to the beginning;
- " 21: From the Buckhorn bridge up the swamp to the old Indian line along the said line to the Buckhorn Road, up the said Road to the beginning;
- " 22: From Muncatl's on the great Road, at the flat swamp, down the said swamp, to the mouth of Roars swamp, up the said swamp to the Road, up said Road to the beginning;
- " 23: From the Kollaway River north Carolina line; to the old Ransom's mill line;
- " 24: Bounded by the old Ransom's line; between Black Water and Kollaway River
- " 25: From the lands lying on the west side of Dr. Bevens Road; ending on the old Ransom's line; thence up the Black Water to David Johnsons, then up the present side to the present Road;
- " 26: From all the lands of David Johnson on Black Water River; up the Cypress swamp, to the Road and down the Road to the present line;
- " 27: From all the lands on the west side of Dr. Bevens Road and up Kollaway swamp, to the old parish line, along the said line to the Cypress swamp; and down the same to the Road;
- " 28: Between Kollaway swamp; Kollaway River and the old parish line;
- " 29: All the lands between Black Water and the Cypress swamp;
