

- " No 30. All the lands from the former parish line between Black Water and Swacoke
to Swacoke lighted down Black creek to Black Water;
- " No 31. From the old parish line to head water Road and down the said Road
to Round hill Swamp: down the same to the beginning;
- " 32. From the Broad Road up Swacoke to the County line and thence to Black
Water and down Black Water to the said Road;
- " 33. Between Round hill the lightwood & the County line;
- " 34. Between Round hill, Black creek, the upmanuck and the County line;
- " 35. Between the upmanuck, Nottaway River and the County line;
- " 36. From the former parish line thence to the head of Black creek, the upmanuck
and the Swamp to Nottaway River down said River to the former parish line;
- " 37. Between Swacoke, Black Water and head Water Road;
- " 38. Beginning at the mouth of Dick's swamp up that Beams Road, along Beams
Road to the Cypress swamp; down that to Nottaway River up that to the beginning;
