

At a special session of the County Court of Southampton held at the Court House thereof, the 12th day of October 1850, pursuant to a warrant issued by James C. Bennett a Justice of the Peace for said County, for the examination of Nathan Parks a free negro for a felony by him committed in this, that he did on the 4th day of October in the year 1850 in the said County, feloniously shoot Benjamin Cobb with intention in so doing to maim, disfigure, disable or kill the said Benjamin Cobb. Present, Saml. B. Storer, Jonathan Emerson, John Cobb, Rich^d E. Barrett and Geo. S. W. Newson, gentlemen Justices

The said Nathan Parks was this day set to the bar in custody of the Jailor of this County, and the examination of the said Nathan Parks is adjourned to the next regular Term of this Court. And the said Nathan Parks moved the Court to be allowed to enter into a recognizance, with security for his appearance before this Court at the next regular Term, which motion the Court entertained, and allowed the said Nathan Parks to enter into such recognizance, himself, in the sum of one hundred dollars, with sufficient security in a like sum. And thereupon the said Nathan Parks entered into a recognizance in the sum of one hundred dollars, with Joshua Preble his surety in a like sum, conditioned for the appearance of the said Nathan Parks before the Justices at the next regular Term of this Court, to answer the Commonwealth of and concerning the offence whereunto he stands charged, and not to depart without the leave of the said Court.
