

Southampton County, Towns:

As per an act of the late Legislature appointing the undersigned commissioners to divide the said County into seven districts, and to designate precinct elections into each, met on the 19th day of April and adjourned over to the twenty six, and then divided the County as follows:

District No. 1. Commence at Cary's Bridge, thence to Bethlehem X Road, thence to Dr. Thomas Mergulants, thence to a Perfect L Pond, thence to Swift Harris, thence to Haly's Bridge to Greenville line. Precinct Election at Scurryville.

District No. 2. Commence at Cary's Bridge, following boundary of district No. one, to Haly's Bridge more side, on the other commence at Jerusalem bridge, thence to James W. Parker's, thence to sign board adding to Monroe, thence to Maule Head, thence along Boon's bridge road to N. Carolina line. Precinct at Groff Keys.

District No. 3. Boundaries of district No. two, thence along N. Carolina line to Northway river, up the said river, to the beginning. Precinct - Joiner's Store.

District No. 4. Commence at Cypress Bridge, thence the road between Benj. Swamy and William Cobb, across Flay Run by Northway Church to Joiner's bridge, and all south and between the two rivers in this district No. 4. Precinct - Murfrees Depot.

District No. 5. Commence at Cypress Bridge, running with Boundary No. 4 to Joiner's bridge, thence up Black water to Blackwater Bridge, thence by the road by Poor House, down Quader road to Vicksville, thence the Cary's Bridge road to Afamossack bridge. Thence up the Afamossack to Super line. Thence to Northway & down to the river to Cypress Bridge. Elections - at Jerusalem & schoolhouse near Ab. Church.

District No. 6. Commence at Blackwater Bridge. From thence by Poor House & Quader meeting House to Vicksville. To Afamossack bridge by Cary's bridge road & thence up the Afamossack to Super line & thence to Lighthouse Swamp & thence down said Swamp to Samsack, down the run to Black water Bridge. Precinct - Berlin.

District No. 7. Commence at the Junction of Seaboard & Black water, up Blackwater to Survey of Isle of Wight line, thence to Super line to Lighthouse Swamp & down said Swamp to the beginning. Precinct - at Joiner's Store.
